This scroll contains an experimental 9th level spell called *spell of longevity*. It was developed on a demi-plane of Pandamonium by the Spider Mage. There, it had a 95% chance of reducing the age of the caster by 10 years and adding 10 years to the caster's maximum life span. The other 5% of the time it killed the caster. However, on the Prime Material Plane the spell is very unstable and should not be cast without assistance from the Wizard's Guild. If you wish to cast this spell, send a copy of the certificate to the Wizards Guild Coordinator, who will adjudicate the results for you. This spell may not be copied into spellbooks or onto another scroll; the chance of getting something wrong is 100% due to the strange notations.

These rings, which must have the same name written on the top of the certificate where the ring name belongs, allow telepathic communication between two wearers who are on the same plane and within one mile of each other. To provide communication, both wearers must be able to speak the same language (since thought is couched in language). The rings must attune to new wearers by being worn for 24 hours before they are used. Once attuned, they allow the passing of thoughts between the wearers. The choice of thoughts passed is up to the wearers, so they cannot be used to read the mind of anyone. Further, they cannot allow one wearer to impart a spell to the other, nor can a spell be cast through the link between the wearers by either wearer (as the rings do not allow one wearer to "see through the other wearer's eyes").
