This blade is normally +1, but is +3 vs cold-using creatures and undead. Further, creatures who regenerate normally cannot regenerate damage from this sword during combat. Instead, the creature regenerates damage from this sword at a rate of 3 points per day. Damage done by strength bonus to attacks is regenerated normally—only the 1d8 damage from the sword is not regenerable. When commanded, it can shed light as per a light spell, and the light takes the form of illusionary flames flickering on the blade.
